### **OUR DRINKING WATER IS REGULATED**

The United States Environmental Protection Agency (EPA) requires all drinking water suppliers to provide a water quality report to their customers on an annual basis. This report is for the period of January 1 to December 31, 2023 and is a summary of the quality of the water we provide our customers. The analysis was made using the data from the most recent EPA required tests and is presented in the following reports. In order to ensure that tap water is safe to drink, the EPA prescribes regulations that limit the amounts of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water that must provide the same protection for public health. Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor, or color of drinking water, you may contact the system's business office. We hope this information helps you become more knowledgeable about what is in your drinking water. It is important to us that you have information about your drinking water so you can have confidence in the product we deliver. ## SOURCES OF WATER AND POSSIBLE CONTAMINANTS

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water before treatment include: -Microbial contaminants such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife; -Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming; -Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses; -Organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems; and - Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

## WHERE DO WE GET OUR DRINKING WATER?

Our drinking water is obtained from two ground water wells in Kleberg County/Riviera, Tx. Well #2 is located at 778 South FM 1546, and well #3 is located at 708 South FM 1546. This water comes from the Gulf Coast Aquifer. The TCEQ completed an assessment of our source water and results indicate that some of our sources are susceptible to certain contaminants. The sampling requirements for our water system are based on this susceptibility and previous sample data. High susceptibility means there are activities near the source water and the natural conditions of the aquifer or watershed that make it very likely that chemical constituents may come into contact with the source water. It does **not** mean that there are any health risks present. Any detection of these contaminants will be found in this Consumer Confidence Report (CCR). #### ALL DRINKING WATER MAY CONTAIN CONTAMINANTS

#### **REQUIRED ADDITIONAL HEALTH INFORMATION**

When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap water for 30 seconds to 2 minutes before using water for drinking or cooking. Action Level:	The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
Avg:	Regulatory compliance with some MCLs is based on running annual average of monthly samples.
Level 1 Assessment:	A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system
Level 2 Assessment:	A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.
Maximum Contaminant Level or MCL:	The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
Maximum Contaminant Level Goal or MCLG:	The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
Maximum residual disinfectant level or MRDL:	The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
Maximum residual disinfectant level goal or MRDLG:	The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

# Mandatory Language for Public Notice

# Triggered Source Monitoring and Reporting Violation: Groundwater Rule

Baffin Bay WSC, PWS # 1370032, failed to collect the required number of triggered source bacteriological samples for fecal indicator monitoring of the groundwater system during April 2023. This monitoring is required by the Texas Commission on Environmental Quality's "Drinking Water Standards" and the federal "Safe Drinking Water Act," Public Law 95-523.

Triggered source samples are used to monitor water quality and indicate if the water is free of fecal indicator bacteria. Following a positive routine total coliform result in our distribution system, our water system is required to submit one triggered source sample for every active groundwater well source. Failure to collect all required triggered source samples is a violation of the monitoring requirements and we are required to notify you of this violation.

# What should I do?

There is nothing you need to do at this time.

# What is being done?

Following receipt of the report for the total coliform positive sample, the required upstream and downstream samples and raw water samples from the wells were collected, delivered to the lab, and found to be total coliform negative. There have been no further positive samples since this time and the operating is currently working with TCEQ to get the violation removed/resolved.
